



Twitter Amazon Gift Card Giveaway

NO PURCHASE NECESSARY TO ENTER OR WIN.

Eligibility. Amazon Gift Card Giveaway (“Giveaway”) is only open to legal residents of the United States residing in the state of North Carolina and who are 18 years of age or older at the date of Giveaway entry. Employees of Civic Federal Credit Union, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of employees are not eligible to participate in the Giveaway. This Giveaway are subject to all applicable federal, state, and local laws and regulations. Void where prohibited. The Sponsor retains the sole discretion to determine any issue of eligibility and its decision will be final.

Sponsor: The Sponsor (“Sponsor” or “Civic Federal Credit Union”) of the Giveaway is Civic Federal Credit Union, 3600 Wake Forest Rd, Raleigh, NC 27609.

Giveaway Period. The Giveaway will begin on August 25, 2021 at 8 a.m. Eastern Time (“ET”) and end on September 8, 2021 at 5 p.m. ET (the “Giveaway Period”). All times are listed in Eastern Time Zone, whether Eastern Daylight Time (EDT) or Eastern Standard Time (EST).

How to Enter. You may enter the Giveaway by submitting an entry in accordance with the instructions posted on the sign at SAFRE for the specific Giveaway. The entry must fulfill all Giveaway requirements, as specified on the SAFRE sign, to be eligible to win. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor. Alternatively, you may submit an entry by mailing a 3”x5” card that includes your name, address, telephone number and email address to the following address: Civic FCU Amazon Gift Card Giveaway, 3600 Wake Forest Road, Raleigh, NC 27609. Mail-in entries must be postmarked by September 8, 2021 and received by September 13, 2021. Regardless of entry method, a maximum number of one (1) entry may be received by any one individual over the course of the Giveaway Period. Additional entries received in excess of the maximum number of entries will be void. The Sponsor assumes no responsibility for incorrect, invalid, terminated, or non-functioning social media accounts or lost, incomplete, late, illegible, or undelivered entries. Entries not complying with these Official Rules are subject to disqualification, at the Sponsor’s sole discretion.

Prize. The prize is one (1) \$100 Amazon Gift Card (the “Prize”). The prize is nontransferable to any other person or entity. No cash redemption or substitution of the Prize will be made, except by the Sponsor in its sole discretion due to causes determined solely by the Sponsor, and then for a prize of equal or greater value. Any and all Prize-related expenses, if applicable, including without limitation, any and all federal, state, and/or local taxes, shall be the sole responsibility of the winner. Winner will be required to provide information, verbally or in writing, to show proof of eligibility in compliance with the specific Giveaway.

Odds. The odds of winning depend on the number of eligible entries received during the Giveaway Period.

Winner Selection and Notification. One (1) potential Prize winner from Twitter will be selected by a random drawing to receive the Prize (“Winner”) on or about September 8, 2021. You need not be present at the time of the drawing to be eligible to win. The Winner will be notified through Twitter direct message, email or telephone within five (5) business days following the drawing. The Winner will be required to respond to the Sponsor within three (3) days following notification as a condition of receiving the Prize.

The Sponsor shall have no liability for Winner’s failure to receive notices due to spam, junk email or other security settings, or for Winner’s provision of incorrect or otherwise non-functioning contact information. Sponsor’s inability to contact the Winner within a reasonable time period, the Winner’s failure to respond or

provide additional information in accordance with these Official Rules, or otherwise accept the Prize, will result in the Winner's disqualification and, at Sponsor's discretion, an alternate Winner may be selected.

Any attempt by an entrant to deliberately damage any website or undermine the legitimate operations of the Giveaway may be a violation of criminal and civil laws. Should such attempt be made, Sponsor reserves the right to disqualify an entrant and to seek damages to the fullest extent permitted by law.

Sponsor's failure to enforce any provision in these Official Rules shall not constitute a waiver of that provision.

By entering, you agree to release and hold harmless Sponsor and its subsidiaries, affiliates, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, damage or expense (including attorneys' fees) that may occur, directly or indirectly, whether caused by negligence or not, from: (i) your participation in the Giveaway and/or your acceptance, possession, use, or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or internet service; (iv) unauthorized human intervention in any part of the entry process of the Giveaway; (v) electronic or human error in the administration of the Giveaway, the announcement of the Winner, or the processing of entries.
